TERMS AND CONDITIONS

INSTALLATION & REMOVAL:

Exhibit set-up times are **9:00-11:00 am** on Thursday, October 6th (unless other arrangements are made with McClellan Business Expo). If your exhibit includes vehicles, aircraft or other large display items - these **MUST** be approved by McClellan Business Expo and alternate set-up times will be scheduled.

NO EARLY BREAK-DOWN OF EXHIBIT BOOTHS WILL BE PERMITTED.

All materials must be removed from **4:00-7:00 pm** on Thursday, October 6th. The McClellan Business Expo is not responsible for any belongings left at McClellan Business Park or Building 251.

REFUNDS/CANCELLATION:

Exhibit fee refunds will only be issued if written cancellation is received by October 1, 2011. Full payment & booth registration must be received and accepted by October 1, 2011.

USE OF EXHIBIT:

All demonstrations and/or promotional activities must be confined to the limits of the exhibitor's reserved space. Standard booth area is 10'x10' - if additional space is required, your booth can be expanded for an additional fee at check out during online registration.

CARE OF BUILDING & EQUIPMENT:

Exhibitors and their agents must not injure or deface the walls or floors of the building, the exhibit spaces or the equipment of the exhibited spaces. The exhibitor is liable to the owner of the property damaged. Combustible materials or explosives are not permitted. The exhibitor shall also comply with all reasonable request of officials of McClellan Business Park and the McClellan Business Expo with respect to the installation, conduct and disassembly of its exhibits.

INDEMNIFICATION:

Vendor, without regard to assignment, lease, sublease or dealer occupancy shall indemnify, hold harmless, defend or reimburse the McClellan Business Expo officers from all losses, claims, liability, damage, actions, judgments recovered from or assesses against vendor or above named indemnity, plus

expenses including, without limitation, attorney's fees. Such indemnification shall not be effective in damage or injury resulting from the sole gross negligence or willful misconduct of the show sponsor, employees, expenses for any injury to or death or and persons, or any loss of through theft or otherwise, or damage to property arising in any way in connection with the use and enjoyment of the vendor of the space, equipment or the show space of hall: arising from the use equipment, devices furnished to McClellan Business Expo and its partners.

ACTS OF GOD:

McClellan Business Expo, and its partners, shall have no liability whatsoever for any matter or thing resulting from strikes, lock-outs' fire or other acts of God: preventing vendors show space being made available to vendor.

COPYRIGHTS:

Vendor hereby assumes all costs and expenses arising from vendors or vendors employee's incorporation or use during the event of any music, written material, dramatic rights, inventions or devices that are subject of any copyright, trademark, trade name, patent, franchise or other contractual or statutory protection. Vendor agrees to indemnify and hold harmless McClellan Business Expo Partnership from any damages, costs or expenses, including legal fees, which might arise out of or in connection with such incorporation or use.

AMENDMENTS:

Show management shall have the full power in the interpretation and enforcement of all terms, rules and regulations and any further stipulations considered necessary for the proper conduct of the show. Vendor agrees to comply with such terms, rules and regulation. Failure to comply with such terms, rules and regulation shall entitle McClellan Business Expo, to terminate obligations under this contract.
